Nomination Package Submission

If your competencies, experience and diversity match the director criteria that Affinity seeks for the 2025 election, please provide the following information to be considered in the 2025 director election. To be considered an eligible candidate, your complete nomination package must be received between **12:00am on December 16, 2024 and 12:00pm on January 13, 2025**. Deadlines are firm and no exceptions will be made. Your nomination package must include the following.

□ Nomination Papers

Nomination of a candidate requires the support of two (2) eligible members of Affinity Credit Union. An eligible nominator must be at least 18 years of age and an Affinity Credit Union member.

□ Candidate Application Form and Candidate Information Sheet

Ensure all statements have been reviewed and answered in full.

Personal Resume

Attach your resume highlighting your education and professional experience related to the 2025 Director Candidate Criteria outlined in the guide.

□ Candidate Statement

Submit a candidate statement that includes:

- 1) why you are interested in serving on the Affinity Board of Directors;
- 2) qualifications, education, or expertise for one or more of the specific skills identified in the Candidate Guide:
 - a) Human Resources and Compensation
 - b) Information Technology
 - c) Business Growth and Transformation
- 3) evidence of your board experience and describe how it would bring value to the Affinity Board;
- 4) demonstrate your leadership experience and how it would bring value to the Affinity Board;
- 5) other work experience, education, professional designations, board and committee experience, and community or volunteer involvement relevant to the director role; and
- 6) any diversity you would like to self-declare which may include gender, Indigenous membership/citizenship, identity, ability, background, culture, skills, perspectives and experiences that you feel are representative of Affinity's current and evolving membership.

The information that you provide will be used in the assessment process and to produce the Director Election Booklet. The election booklet supports members to make an informed vote for candidates on the ballot.

Write in first person narrative, don't exceed 450 words and submit your statement electronically in Microsoft Word file format or in the body of an email.

Information provided will be published in a format that Affinity determines appropriate for director election purposes. If necessary, candidates selected to stand for election may be asked to provide additional information.

Current Photograph

The photograph must be a high-resolution head and shoulder shot taken in colour against a plain or neutral background and submitted electronically in a digital file format.

All director candidates are subject to a comprehensive criminal record and background check, and verification of independence as outlined in Affinity's Responsible Persons and Board Independence policies.

- 7. I do not, nor does my spouse if applicable, have loans or credit in arrears (in excess of 60 days) with Affinity Credit Union in the previous twelve (12) months or have any judgement registered against me.
- 8. I am not in a bankrupt status.
- 9. I am not a professional adviser to Affinity Credit Union.
- 10. I am a member of Affinity Credit Union and will use Affinity as my primary financial institution.²
- 11. I will accept the office, if elected, and keep in strict confidence the information or transactions of any member that comes to my knowledge or attention.
